

***Brevibacillus* Expression System Related Products  
Purchaser' s Agreement to the Terms and Conditions of Sales**

*Brevibacillus* Expression System–related products have been developed and manufactured by Higeta Shoyu Co., Ltd. and marketed by TAKARA BIO INC. *Brevibacillus* Expression System–related product(s) (expression vectors, competent cells) (hereinafter referred to as the “PRODUCTS” ) are covered by WO02/064800 and WO2005/045005, which are owned by HIGETA SHOYU. By purchasing PRODUCTS, Purchaser agrees to the following:

1. PRODUCTS are for research or laboratory use only. PURCHASER understands and agrees that PRODUCTS shall not be administered to humans or animals, and shall not be used for pharmaceutical, *in vitro* diagnostic, or any commercial purposes other than internal research. Commercial uses require a separate license from HIGETA SHOYU.
2. PURCHASER shall not modify PRODUCTS including, but not limited to said sequences. The adjacent multicloning site (MCS) is exempt from this restriction.
3. PURCHASER shall not utilize any partial sequences from PRODUCTS for the purpose of new plasmid construction using the *Brevibacillus* Expression.
4. PURCHASER shall not transfer or sell copies of PRODUCTS, components of PRODUCTS, derivatives of PRODUCTS, and/or products obtained through the use of PRODUCTS (collectively “DERIVATIVES” ) to any third parties.
5. PURCHASER' s order of PRODUCTS will be delivered only when this Agreement is signed and returned to Takara Bio or one of its subsidiaries. TAKARA BIO is required by its licensing agreement to submit a report of all purchasers of HIGETA SHOYU.
6. By purchasing PRODUCTS, the PURCHASER agrees to the terms and conditions herein. These terms and conditions cannot be modified or amended without express written agreement by an officer of TAKARA BIO. TAKARA BIO' s failure to object to provisions contained in any purchase order or other form of document from PURCHASER shall not be construed as a waiver of the terms and conditions herein or an acceptance of any such provision.
